

COUNT ONE

On or about May 21, 2023, in Hot Spring County, Arkansas, DEREK SCOTT FINKBEINER accessed information or obtained information collected and maintained by A.C.A. § 12-12-201 et seq., for a purpose not specified by that subchapter, and he accessed or obtained information for the purposes of furthering the commission of a misdemeanor offense or felony offense against the peace and dignity of the State of Arkansas. COUNT TWO

On or about May 21, 2023 in Hot Spring County, Arkansas, DEREK SCOTT FINKBEINER offered or agreed to pay a fee to a person to engage in sexual activity with him or her or another person against the peace and dignity of the State of Arkansas.
